

# Curbside Collection Guidelines

### RECYCLING PREPARATION GUIDELINES

- Recycling bins may be set out every week the night before your pick up day or no later than 5:00 a.m. on your pick up day and should contain recycled items **ONLY**. Recyclable items can be loose and co-mingled together in your bin.
- All residences must have a recycling bin at the curb to identify your stop for recycling collection that day. Residents may purchase additional bins at the Freeport Recycling Center or from Gill's Freeport Disposal for \$12.00.
- Recycled items in your bin must be empty and free of food, drink, or any residue.
- Newsprint & other paper products can be stacked on the bottom of the bin with all other materials co-mingled on top. This may help to prevent blowing on windy days.
- **Please do not dispose of plastic bags in your recycling bin or use them to contain excess recyclable items as these contaminate the recycled material.** Styrofoam and blister packaging are also not recyclable and should be set out with your trash.
- In the event that you have additional recyclable items, you may place excess items in a separate paper bag, cardboard box or container clearly marked "recycling" beside the bin.

#### METAL PRODUCTS

**Tin & Aluminum:** Cans, formed aluminum and tin containers including old pie and cake tins. Empty and rinse container completely. Place lids inside of cans. Labels do not have to be removed.

#### GLASS PRODUCTS

**Glass Jars & Bottles only:** Empty and rinse container completely. Labels do not have to be removed.

#### PLASTIC PRODUCTS

**Plastic Jugs and bottles:** Containers with numbers 1 through 7 on the bottom (Except Styrofoam and blister packaging). Empty and rinse container completely. Labels do not have to be removed.

#### PAPER PRODUCTS

**Newsprint:** All newsprint is acceptable.

**Junk Mail:** Includes envelopes, fliers, brochures, advertisements, old papers, white & colored papers.

**Other Paper Items:** Catalogs, magazines, phone books, soft cover books (hard cover books need covers removed).

**Brown Kraft Paper Bags:** Grocery, shopping, lunch bags, etc.

**Corrugated (Cardboard Boxes):** Break down, bundle or stack in manageable sizes not exceeding 3 foot square.

**Other Cardboard:** Food, clothing, shoe, toy & game boxes, beverage cartons, soda boxes, etc.

### SUBSCRIPTION YARD WASTE INFO

- Residents should call Moring Disposal or Gill's Disposal to sign up. There is a pre-paid cost each season which includes weekly service and rental of one 65 gallon landscape toter.
- Yard waste needs to be placed **ONLY** in the provided toters. Landscape bags, cans, bundles or any other containers besides the supplied toters are prohibited.
- Additional toters may be rented and pre-paid for each season from your service hauler.

**Yard Waste Schedule:** Weekly collection will be on Wednesday for Moring Disposal residents and Thursday for Gill's Disposal residents; each from the middle of April through the middle of November, weather permitting.

- Residents should place yard waste at the curb by 5:00 a.m. Any yard waste placed at the curb after the truck has gone by will not be picked up until the following week's collection day.

### GARBAGE PREPARATION GUIDELINES

- All garbage items must be set out the night before your collection day or no later than 5:00 a.m. on your pick up day.

**Holiday Schedule: Pick up is delayed one day when these holidays fall on a weekday that is on or before your collection. In instances of weekend holidays, please see our website, [www.moringdisposal.com](http://www.moringdisposal.com) or contact our office.**

- All trash must be placed in a refuse bag or container no larger than 35 gallons in capacity and 35 lbs. in weight. Each single family dwelling is allowed up to 2 bags or trash cans each week. Residents using smaller than 35 gallon bags will be allowed more within reason.
- Residents with additional trash can set out extra bags or trash cans with a \$0.50 extra item sticker securely attached around the neck of the bag or clearly visible on the can. Loose uncontained items will not be picked up. Stickers may be purchased at the following locations:

**Bulky Waste Service:** Single furniture items and items that do not *easily* fit in a 35 gallon container are considered bulky waste. Bulky waste *excludes:* electronics, TV antennas, construction and remodeling material, landscape timbers, old car parts, etc. Residents requiring pick up of these items should contact their hauler to make arrangements. Charges may apply; residents are encouraged to seek scrap metal dealers for recycling metal items.

**Electronic items:** Small and large electronics are no longer accepted at Illinois landfills. Please visit our website [www.moringdisposal.com](http://www.moringdisposal.com) or your local electronic/appliance store for electronic recycling opportunities.

**Construction/Demolition Debris:** Material from construction and remodeling (including toilets, carpet, wood, drywall, rock, sand, brick, dirt, etc) are not included with the weekly curbside collection even in small amounts and therefore, need special arrangements. Residents requiring pick up of this material can contact their hauler for container sizes, pricing and availability.

**Major Appliances (White Goods):** Residents may contact their hauler to make arrangements for removal. Charges may apply and certification from a licensed technician needs to be provided for refrigeration units showing the Freon has been removed.
